3. Attend ORIENTATION CLASS- (REALTOR® Awareness Course) which includes Professional Standards Class and MLS Training

(Schedule of dates enclosed)

A. An applicant shall take and satisfactorily complete the required REALTOR® Awareness Course and Professional Standards Class within 90 days. If the courses are not completed, the application fee may be forfeited and the applicant may be required to reapply for membership. Also the mandated MLS class is taken at this time. To participate in our MLS, you must also attend the MLS Training Class within 90 days from the date of your application. If you do not attend the MLS Training Class, your access to the MLS will be turned off.

4. Board of Directors Review.

A. Upon completion of the above steps, the application is submitted to the Board of Directors for final review and approval. Once the application has been approved by the Board of Directors, there will be no refunds. (See Bylaws, article V, Section 3)

5. Induction.

A. After the Board of Directors final approval, the applicant will be inducted at the REALTOR® Awareness Course or at a mutually convenient time prearranged with the Membership Coordinator.

B. Applicants must be inducted within 90 days after final approval by the Board of Directors or the applicant may be required to reapply for membership. (See Bylaws, Article V, section 3)

Note: Association policy states that all new members, resignations and terminations may be bulletined to the membership.
